REFUNDS:

Registration fees: are non-refundable.

Tuition: Parents/Guarantors are expected to pay the full tuition amount. Requests for tuition refunds are at sole discretion of Aqsa School.

FINANCIAL ASSISSTANCE:

The school depends upon tuition as its primary source of income. As such, every family is expected to meet the prescribed financial obligations. A limited amount of financial assistance is available through the donors of Aqsa School. In order to qualify for this assistance, families must meet certain financial criteria. The application and further details regarding the application and its' deadline are available in the business office.

SCHOLARSHIPS:

Any current or new student entering the junior high and high school grades at Aqsa School with a GPA of 3.5 or higher is eligible to receive a 50% discount off of the first years tuition.

Other scholarships may be available at the time of registration, please ask the Business Office for any additional information.

DELINQUENT TUITION AND FEES:

Tuition payments are due in Aqsa School business office on the 10th of each month.

If families are having financial difficulties in meeting their obligations, they are encouraged to contact the school early to discuss potential financial options. Please be aware, that failure to make scheduled tuition payments will result in one of the following actions:

- Termination of student from Agsa School
- Prohibit of students' ability to take scheduled mid-term/ final exams
- Student's records/report cards will be withheld
- Student will not be allowed to register for upcoming academic year
